While much of 2009 was focused on building an organizational foundation that can sustain significant future growth in our programs, children's lives continued to be impacted through our current programs. Through our year-round mentoring program mentors provided over 3000 hours of positive adult nurturing time to 31 children of prisoners. In fact, 2009 marked the 7-year anniversary for several of these mentor matches.

In addition, 12 children attended a weeklong camp geared specifically for children of prisoners. At the camp, Bridge Builders for Kids provided a special speaker who had experienced many of the same things as a child that these children are currently going through. Her
