Resume/Vitae: Please submit a resume/vitae that clearly indicates your affiliations, ministry and non-ministry, along with your full name, and qualifications.

Endorsement: You should have your Senior Pastor, District Overseer, State Overseer/Bishop, and/or Regional Bishop to submit a letter of endorsement of your candidacy as an Instructor for the Youth Division. If you are not a member of Full Gospel and/or your local ministry is not a FGBCFI ministry, please provide a letter that clarifies that detail.

Registration: Each prospective instructor must have confirmed conference registration prior to submitting instructor application. FGBCFI does not arrange and/or pay for any lodging and/or travel for any invited instructors. This cost is individually incurred.
